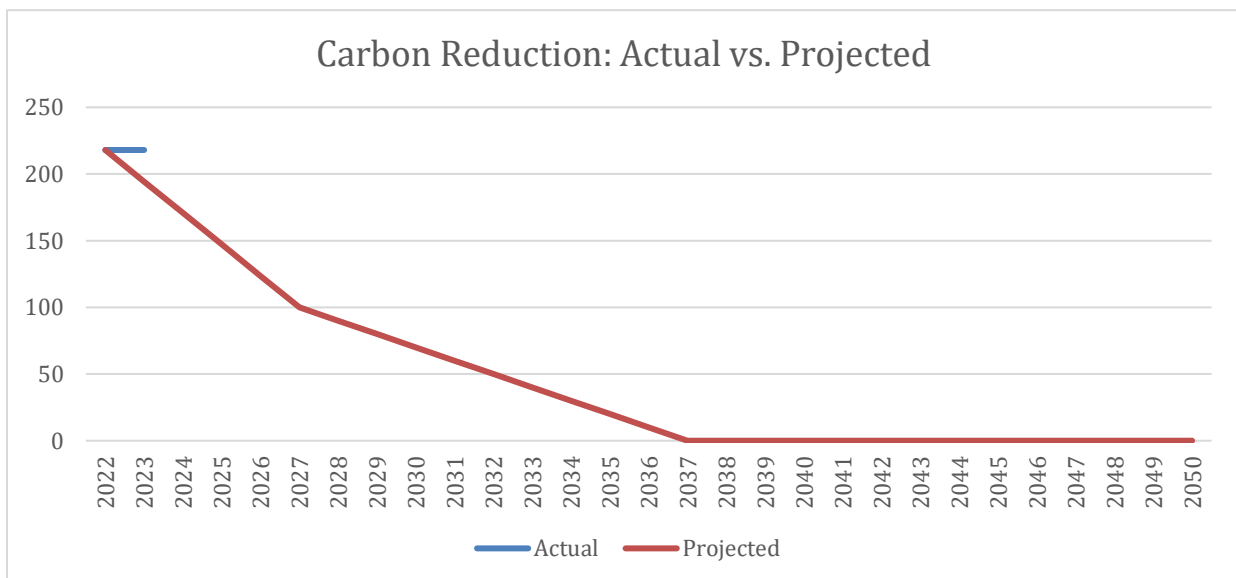
Emissions reduction targets

To continue our progress to achieving Net Zero, Twin has adopted the following carbon reduction targets:

Twin projects that carbon emissions will decrease over the next five years to **100 tCO₂e** by **2027**. This is a reduction of **74%**

This is Twin Training International's first year of reporting our carbon emissions. We have, however, already implemented a Carbon Reduction Plan as part of our Environmental & Sustainability Policy, to:

- Reduce Electricity consumption in all sites
- Minimise Waste produce and promote recycling
- Minimise printing saving on paper and ink/toner
- Minimise use of transport and promote use of public/alternative transport where transport is unavoidable
- Increase staff awareness of sustainability
- Enable an environmentally safe working environment


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
